It was noted that preliminary state revenues reached \$20.507 billion in FY 2011. With this level increase, the "accelerator" provision in the June 30, 2010 Memorandum of Agreement will take effect. It is not yet clear where the funding for the accelerated increases will come from.

The MSCA will seek a written statement from the BHE regarding possible health insurance increases and the costing of accelerator provisions.

Other Executive Branch units have negotiated new bargaining three-year agreements. There are many issues that need to be taken into consideration regarding the timing of MSCA contract negotiations.
