There was an anti-Semitic incident on campus recently. There was informational picketing to protest the incident.

Fitchburg:

The Fitchburg Chapter recently sponsored an event on campus. It was well attended.

The campus climate survey is being conducted on campus.

There is a digital learning group on campus.

There is discussion on campus regarding campus policies regarding online courses (which courses should be online).

There was one 0% PTR rating. The rest of the PTR candidates received 6% increases.

Some deans on campus are having difficulty interpreting the contract regarding evaluations.

Bridgewater:

There was a failed dean search. The interim dean comes from the faculty.

Chairs are not sharing information with faculty regarding anonymous student complaints that come forward.

The chapter's constitution and bylaws needs to be updated.
