## MCCC Motion

The MCCC motion was distributed and discussed.

The following motion was moved and seconded:

The MTA publication entitled, The Public Schools and Colleges Our Students Deserve, prepared by the MTA's Education Policy and Practice Committee copyrighted 2018, was

created with no input from the MSCA. The MSCA demands input into the content of the publication and insists that the publication in its current form not be distributed. Producing a policy document involving higher education, without any input from the MSCA, violates our philosophy of a democratic union.

Early College plans are emerging. It was requested that chapter presidents find out how they are being implemented. Thus far, they are happening at Salem and Worcester. This affects both the MSCA and PreK-12 units. Discussion followed.

Database Transition

The member database conversion is underway. Treasurer Love continues to meet with MCCC staff to work on the conversion. The complete conversion should be done by December 1, 2018.

Treasurer's Office Computers

Bridgewater State University's ITS department assisted the Treasurer's Office during a significant hardware malfunction of its office computers. Treasurer Love reported that there are now two functioning computers in the office, with the hopes of a third computer becoming operational in the near future. This additional, third computer, will be used by a future staff member.

# Monthly Expenses

Treasurer Love distributed the monthly expense handout to board members. Discussion followed.

It was noted that the anticipated loss of \$17,000 in revenue, due to the Janus decision, will not happen. This is because we have gained new MSCA members, who were formerly agency fee payers.

There was confusion, by the provost, regarding APR use.

There have been two unfair terminations of tenure track faculty members.

There is a new AVP for Academic Affairs, who continues to learn the procedures and policies regarding staffing committees.

The dean for graduate studies resigned as of November 1.
