The teach-in on higher education funding was very successful. There were 126 classes and 69 faculty participated. Trustees, state representatives, APA and AFSCME employees also participated. The MSCA and MTA provided pizza for the participants.

The Executive Committee is very active. As part of a marketing tactic, an op-ed piece written by Salem State students was published in the local newspaper.

There was an enrollment meeting to discuss the health and vitality of the institution.

The School of Nursing is still on warning by the board of nursing. The chair of the School of Nursing resigned.

There are union meetings held two times a month.

The VP of Administration and Finance announced that there is a \$1 million gap in the budget.

Enrollment is down.

Southern Vermont College closed and MCLA has accepted a number of their students. MCLA would like to begin a radiology program that would take over Southern Vermont College's program.
