### Salem

At a recent Board of Trustees meeting, the importance of a liberal arts education was discussed.

Faculty listed on the released retrenchment plan received handwritten notes from the provost.

### Mass Maritime

Sea Term is a mess; the Academy is still trying to decide on whether to hold Sea Term due to COVID-19 concerns.

There administration asked several faculty to consider holding their final exam on a Saturday.

#### **MCLA**

Quiet on campus. Students were sent home in early April due to a COVID-19 outbreak. There is a new VP of Academic Affairs, Richard Glazier.

Chapter elections are on May 22<sup>nd</sup>.

#### MassArt

Four presidential candidates came to campus four weeks ago. The Board of Directors voted on one of them to serve as the next president of Mass Art; the person selected is Mary Grant.

#### Framingham

A meeting with the president, provost and deans was held May 21<sup>st</sup>. During the meeting they were asked why they are balancing the budget by cutting faculty lines. The president was optimistic about requiring students to be vaccinated and about enrollment.

#### **Fitchburg**

A meeting was held recently with the president and provost.

The Health and Safety Committee is reconvening.

A building housing three faculty departments is in disrepair. Faculty have been complaining about these issues for 40 years. Union leadership is working with an MTA to get the building fixed so that it is more habitable.

Bridgewater

Governance is pushing back on a permanent pass/no pass policy.

The chapter president spoke before the Board of Trustees. During the meeting, the university president said that it was unclear when the university would receive the third round of COVID money.

Students received link to the SIR II student evaluations.

The university has been reluctant to work with union leadership regarding advocacy on safety issues. Questions were developed by the chapter's executive board to ask university administration. Faculty teaching remote now would have a choice to teach remote in the fall. The chapter is asking for inspection standards, in particular for classroom airflow.

Questions regarding continuing COVID-19 testing in the fall as vaccinations are more widely available. Students are resistant regarding testing.
