#### **MOTION**

## **MOVED:**

1.) That the MSCA President send a letter to Governor Healey urging her to appoint, through a fair and transparent process, Massachusetts State College Trustees who are advocates of public higher education, who have educator experience or familiarity with public university environments, who are willing to spend time getting to know our institution's students, employees and programs, who are committed to social justice and anti-racism work, who see the value of a liberal arts education for our students and the greater good, and who understand and respect shared governance.

- 2) That the MSCA president direct the MSCA Legislation Committee to develop a proposed bill with allies in the State Legislature to require that Boards of Trustees at institutions of public higher education in Massachusetts include a faculty/librarian representative.
- 3.) That the MSCA Board of Directors implement a Trustee outreach campaign that helps MSCA Chapter members engage with their Trustees, such as attending Board of Trustees meetings, inviting Trustees to department events, and involving members in recruiting and nominating new Trustees.

## **SUBMITTER'S RATIONALE:**

The Governor of the Commonwealth appoints all Massachusetts State College Trustees except for student-elected trustees and the alumni board-appointed trustees.

These Massachusetts State College Trustees are the stewards of our institutions with the responsibility to hold the values and public purposes of our colleges in trust for current and future generations of students and educators.

These Massachusetts State College Trustees serve their respective campuses by providing financial oversight through budget review and approval, by participating in institutional planning including review and approval of the campus strategic plans, by approving the tenure and promotion of faculty and librarians, by providing public support and advocacy for our institutions, and by engaging in philanthropy for their respective campuses.

Thus it is very important that we play a role in influencing the appointment of Massachusetts State College Trustees who hold a deep commitment to public higher education and engage in and relationship-building with them.
