# **Budget Committee NBI**

Whereas the MSCA and its members needs easy access to the financial information of the universities in which they work,

Whereas a transparent budget process helps members both understand our respective university budgets, gather information about how state allocation shapes university financial decision making and student-fee structures, and provides members with the formal opportunity to make proactive suggestions about how to best allocate university funds,

Whereas not all MSCA campuses have formal budget committees where members can shape the agenda and direct discussions,

Whereas Article VII D3c of MSCA/BHE Contract enables each campus to create special committees through the consent of the University President, MSCA chapter President and a majority vote of the All University Committee, which could include a budget committee,

Whereas the current one-year bargaining negotiations may preclude language items such as the creation of individual university budget committees,

Be it resolved that the MSCA President, MSCA Board of Directors and MSCA Investigative Budget Committee reach out to local chapter presidents and Executive Boards to assess their interest in creating a budget committee on their campus.

Be it resolved that if local chapter presidents, Executive Boards and All University Committees want assistance, the MSCA President, MSCA Board of Directors and MSCA Investigative Budget Committee provide help to chapters to formulate their respective budget committee proposals and work with them to implement these on their campuses.

## **SUBMITTER'S RATIONALE:**

Due to the overall impact that the budget has on our students' learning conditions and our learning conditions, the MSCA should provide a supporting role to create contract-style budget committees. This AUC created committee will promote transparency and give members additional powers over the budget process.

## **SUBMITTER'S COST & WORKLOAD ESTIMATE:**

If local campuses want to implement these committees, it would require significant coordination between statewide leadership, chapter presidents, chapter Executive Boards and chapter AUCs. University presidents and CFOs would also be part of these discussions, as the only way to create these committees requires a university president's agreement.

Other New Business Items **WITHOUT** budgetary implications will be considered during the meeting in the order in which they are received.
